Since its establishment in 1980, the Centre has distinguished itself by issuing dozens of model laws through Arab technical committees created under the Sanaa Plan for the Unification of Arab Legislation, as well as hundreds of scientific studies published in its annual series and in the periodic issues of its peer-reviewed journal, "The Scientific Researcher".

The Centre has also played a notable role in organising international conferences, most prominently the Conference on the Recovery of Stolen Assets held in Baghdad under the patronage of the Prime Minister of Iraq and with the participation of the Secretary-General of the League of Arab States, and the Conference on Counter-Terrorism held under the patronage of the President of the Lebanese Republic and attended by the Secretary-General of the League. Additionally, the Centre has administered the League of Arab States Award for Law and Justice, held in Beirut and Mauritania.

The Centre operates under the supervision of the Council of Arab Ministers of Justice, which plays a pivotal role in advancing Arab judicial cooperation. As the Council's scholarly arm, the Centre remains committed to following up on the adoption and implementation of the outcomes of periodic judicial meetings and specialised technical committees, in line with the aspirations of Their Excellencies the Ministers of Justice to advance Arab justice and open new horizons for its institutions.

Ladies and Gentlemen,

The development of judicial personnel, the allocation of human and technical resources, and the integration of modern technologies into development strategies have become matters of paramount importance, particularly as artificial intelligence enters the legal and judicial sphere and digital transformation dominates most sectors. Accordingly, the Centre has sought to benefit from international expertise by cooperating with specialised international organisations and institutes to facilitate the exchange of knowledge.

In addition, the Centre has worked to draw on Arab expertise by assigning Arab specialists to undertake regional tasks that strengthen cooperation and facilitate the exchange of experience among member states. The Centre reaffirms its ongoing commitment to advancing its programmes, enhancing its cooperation with counterpart international bodies, and drawing on their advanced experience in order to transfer such knowledge to Arab judicial institutions for the benefit of all and in support of the broader process of modernisation and development.
